The team provides psychological and psychotherapeutic counseling and informs the victims about their rights (information on the law of victims of criminal offenses, the judicial procedure and the law of compensation of victims of violent crimes) and can accompany them during the judicial process. The service also offers a therapeutic group for victims of domestic violence. Consultations are free and are by appointment only

- * Luxembourg implements for the moment the Directive (UE) 2017/541 of the European Parliament and of the Council on combating terrorism and replacing Council Framework Decision 2002/475/JHA on combating terrorism., which contains specific articles for victims of terrorism.

- * YES: identical treatment.
- 7. Do you foresee to cover urgent expenses of victims for travel expenses, funeral expenses, repatriation of bodies, etc?
- * Our office has a governmental budget for helping victims. We can cover partially urgent expenses (depends on the amount of the expenses). For exceptional expenses we can also collaborate with the authorities and ministries in charge.
- 8. Do you intend to train psychologists to provide specific assistance to victims of terrorism in the short and long term?
- * In our service we are all psychologists specialized in psychotherapy for PTSD and trauma. We can offer specific assistance in a short and long term perspective.

- * We think this could be helpful.
- 10. What information must a victim of an attack provide to your national authorities to obtain attention and support?
- * For consulting our service no special information has to be provided. NO information (medical certificate, formal complaint or police report...) has to be provided to get support of the service.
